Upcoming **Open Season** 2022 by Adriatic LNG: additional information on offered LNG regasification capacity and market test for up to 2 BCM/year of additional LNG regasification capacity.

Following the publication of the [Information Leaflet](#) on the upcoming **Open Season** 2022, Adriatic LNG is providing additional information to gas and LNG market operators.

Adriatic LNG welcomes gas and/or LNG market players interested in the **Open Season** 2022 process, a very attractive opportunity to subscribe existing long-term LNG regasification capacity with a major energy infrastructure operator in the Mediterranean area as well as discuss the possibility to invest in capacity to be built in the near future.

1. Available LNG regasification capacity offered in **Open Season** 2022.

2. Provisionary schedule.

As already provided for in the *Information Leaflet*, **Open Season 2022** is expected to start by the end of this month of May by carrying out the non-binding qualification phase and end in July 2022.

3. Market test regarding new LNG regasification capacity to be built: increase from 0.5 up to 2 BCM/year.

In reference to the market test on LNG regasification capacity increase to be built, Adriatic LNG is happy to announce that it is ready to assess an increase of capacity from 0.5 BCM/year up to 2 BCM/year from end year 2025 onward

("TBB Capacity"). Such TBB Capacity requires capital investments, permitting and building activities.
